27th Annual General Meeting was held on Monday, 24th July, 2017 at 3.30 P.M. at Yashwantrao Chavan Pratishthan, Chavan Centre, Cultural Hall, 4th Floor, General Jagannath Bhosale Marg, Mumbai – 400021. Shri S. Sridharan, Sr. Vice President & Company Secretary welcomed the Chairperson, Directors, Statutory Auditors, Secretarial Auditors and shareholders present in the meeting. The requisite quorum being present, Company Secretary called the meeting in order.


Company secretary further conducted the proceedings of the meeting and following items were conducted in the meeting which were passed with requisite majority as per the report given by:
