Please refer to the show-cause notice issued to company vide letter no. NHB (ND)/DOS/Sup./A-1682/2020 dated 18-02-2020 on the captioned subject and the reply of the company vide its letter dated 28-02-2020.

2. Based on the examination of the issue including the submission made by the company in the matter, the National Housing Bank has decided to levy a penalty of **₹1,000/- (Rupees One Thousand only) plus applicable GST of ₹180/-** @ 18% on account of delayed submission of Half Yearly Return (Schedule – II) for the period ended on 30-09-2019.

3. The company is directed to credit the total penalty amount of ₹1,000/- plus applicable GST of ₹180/- @ 18%, as per the Bank details enclosed at Annexure-I, within 14 days from the date of receipt of this letter. Further, the Company is advised to separately disclose, in the "Notes on Accounts" to the Balance Sheet in its next Annual Report, the details of the penalty imposed by National Housing Bank, in terms of the provisions of paragraph 29(5) of the Housing Finance Companies (NHB) Directions, 2010. Further, the company shall also prominently display the penalty levied by NHB on its website, as per NHB's Policy Circular No. 93 dated February 15, 2019.
